

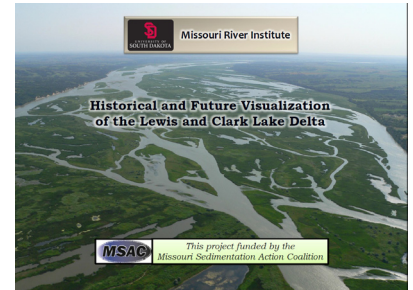

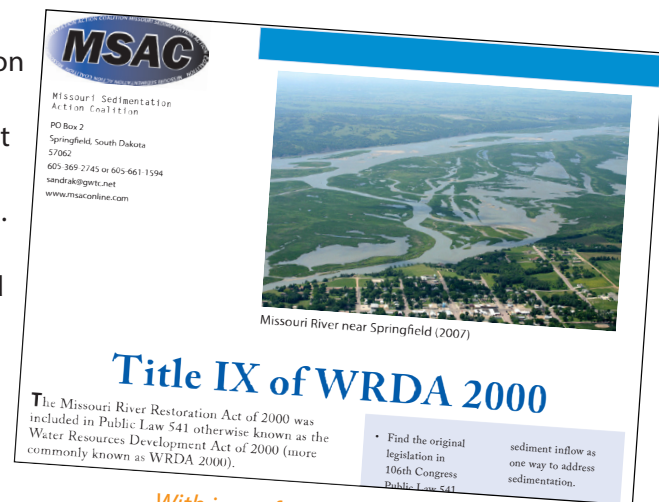
### Initial Contacts Made in Exploring Potential Title IX Task Force Projects

Getting the Title IX Task Force and its objectives off the ground has been no easy task. Meetings have been on hold as task force members need to be appointed or reappointed. For about one year, the task force appointments have been under federal legal review.

In 2014, MSAC encouraged two volunteers to contact counties regarding Title IX and their interest in pursuing projects.

This contact has encouraged discussion and sparked new questions about what existing programs could also be utilized.

Much more work and education needs to take place. MSAC hopes to enlist an entity to assist.



### News Coverage - 2014

Sedimentation issues received substantial news coverage in the media in the states of South Dakota and Nebraska and Sioux City, Iowa.

## MSAC Continues Education Efforts: Knox County Fair and SD Discovery Center in Pierre

Several hundred county fairgoers took a look at the MSAC booth at the **131st Knox County Fair** in Bloomfield, Nebraska August 7 - 10. MSAC handed out free copies of its DVDs and flyers. In 2012, more than 11,000 attended the fair.

In July of 2014, Larry Weiss, President of the MSAC Board of Directors, stopped by the **South Dakota Discovery Center** in Pierre where MSAC had a poster on display. Anne Lewis, Special Projects Director at the SD Discovery Center, was on hand. The SD Discovery Center administers 319 Watershed Education mini-grants.

## MSAC Maintains Office at Corps of Discovery Welcome Center South of Yankton

Each year, hundreds of visitors from all over the country stop at the Corps of Discovery Welcome Center on US Highway 81, two miles south of Yankton.

The Welcome Center staff also added new activities including a farmers market boosting traffic. Visitors come with a variety of interests including birding, geocaching, casinos, and, of course, the river.

MSAC continues to explore ways to enhance Missouri River education available at the center which is just a couple of miles from Gavins Point Dam on Lewis and Clark Lake of the Missouri River.
